- 2. A motion to approve the agenda was made by C. Oraw, seconded by T. Taylor. Motion carried.
- 3. A motion was made by K. Staiert to approve the December 15, 2022 minutes. Motion was seconded by M. Kaplan. Motion carried.
- 4. Recreation Supervisor, Danae Edwards, led a discussion recapping FamilyFest. The Board was happy with the event with a full parking lot and lots of vendors. Cleanup went well and got done quickly. Vendors gave Board Members good feedback saying they enjoyed participating in it. Inflatables were a hit and busy. Caricature vendor & Spiderman was a hit along with the M&M cookies.

- 9. Assistant Director, Josh VandeKamp, presented to the Board proposed rental rate increases for facility rentals within the Parks & Recreation Department. A motion was made by M. McAtee and was seconded by B. Crow. Motion carried.
- 10. Directors Report, by Matt Jermier: Heart of the Warrior Trail Project bids received (9 total bidders) and came in under budget. Heart of the Warrior west extension on the street now and accepted bids on February 8. Stratford Crossing Park will be out soon as well with an opening on March 2. The department continues to seek seasonal staff for Rec, Parks, Golf and Triumph Park.
